
W ramach powierzonych zadań, firma zajmowała się:

Powyższe działania zostały ocenione przez Państwową Inspekcję Pracy na drodze konkursu „Buduj Bezpiecznie”, w którym Generalny Wykonawca Serveone Poland Sp. z o.o. Wrocław został nagrodzony II miejscem w kategorii „Budownictwo Przemysłowe”, zaś inwestor LG Chem dodatkowo wyróżniony.
